Why are we raising money?

We as a church family have agreed that we are in need of additional space to provide for our current and future needs as a church. The funds raised during this campaign will go directly to fulfilling these needs.

How much money are we trying to raise?

Phase 2 -Project Cost.....	\$800,000
Current Funds On Hand.....	\$280,000
Basic Need	\$540,000

Can I just shift my regular Commitment over to the campaign?

Commitment to this campaign needs to be over and above your regular tithing (giving). Your regular giving funds our ongoing ministry which includes Missions, Ministry Programs, Staff Salaries, Regular overhead. Some have continued to give above and beyond through Phase 1 and continue to give to this day. Others began giving above and beyond specifically to Phase 2 last year so that we could continue planning and saving.

How can I give?

Ways to give:

Form	Benefits
Cash (one-time gift)	Tax deduction
Cash (pledge over two years)	Tax deduction / spread gift over two years, maximizes Commitment potential
Appreciated Assets (stock, bonds, real estate, paid up life insurance)	No capital gain / direct transfer / tax deduction on appreciated asset
Life Income Arrangements (annuities, trusts)	Predictable rate of return / income stream for life / tax deduction based on remainder interest calculation expands gift capacity
Personal Property of Gifts in Kind (building materials, architectural services, diamonds, boats, artwork, etc.)	Tax deductible for appraised value / reduces potential costs for church / maximizes the financial resources and saving for church / enhances public recognition for the donor

How long will I have to pay my commitment?

The pledge period is for two years.

How do I make my commitment?

Commitment cards will be available for every person in the Church. They have been mailed to each household but will also be made available on commitment weekend. Simply fill out the card with your information and commitment amount and then seal it in the envelope provided.

•It is important that we hear from everyone, so each person will be asked to fill out a commitment card and turn it in regardless of monetary amount.

When do I begin fulfilling my commitment?

You can begin today! Please go to our website and chose the “give” button. From there you will be invited to make recurring gifts or a one-time gift directly from your account. Of course some prefer to give monthly, quarterly, or a lump sum. The earlier commitments are fulfilled the sooner we can move forward with our project.

Will commitments be announced?

Commitment numbers will be shared in total, but individual personal commitments will remain private unless express permission is granted by the person.

Will there be pressure to give or to make a commitment?

Your financial commitment will be between you and The Lord. We have made a conscious effort to apply no pressure to anyone or set a specific expectation as to what they should give. We have chosen to communicate by e-mail and letter with minimal announcement from the stage during worship services. Our desire is for your commitment to express your trust in God, spur you on to continued personal growth in your relationship with Him and ultimately please Him.

What is the anticipated start date for each phase of this project?

A start date will be announced when we reach \$400,000 in commitments collected. Presently we are at \$280,000 as of 1/24/22.
